MEETING OF THE WORKING GROUP UNDER E-**GOVERNANCE STATE COMMISSION**



Working group, which was created in the scope of the state commission for the development of e-governance in Georgia held a meeting in the Ministry of Justice of Georgia, and discussed issues about these projects: Central system of identification, Unified governmental network, data exchange infrastructure, citizen's portal, unified information registry of the state.

Working group includes representatives from different Ministries and Agencies.

With the use of information-communication technologies the state commission for the development of e-governance in Georgia aims to create a more developed management system which serves for the effective, and simplified methods of communication between a citizen and a state. As a result, a citizen is given a chance to use state services everywhere, any time, without having to leave office or house. One more important direction is the support of internalization of the country and working on this matter.

It is also important to use fast and secured ways of exchanging information between state organizations with the help of information-communication technologies and relevant platforms. This will result in increased effectiveness and transparency of state governance processes (Continued on P.2).





As the usage of information-communication systems is an important condition for carrying out e-governance project, the need for security of these systems arises as well. Therefore, the country carries out cyber and information security reforms, which is an important aspect of the commission's work.

As a result of the implementation of the projects planned by the commission Georgia is positioned as a country which is technologically promoted in the region, all of which implies attractive investments, and closeness to EuroAtlantic space.

Organizational-technical support of the commission is carried out by the Data Exchange Agency of the Ministry of Justice of Georgia.

The commission is chaired by the Prime Minister of Georgia. The deputy chair of the commission is the Minister of Justice of Georgia.

EMPLOYEES OF THE DATA EXCHANGE AGENCY HELD A TRAINING FOR THE REPRESENTATIVES OF THE COMMERCIAL BANKS



Employees of the Information Security and Policy Division of the Data Exchange Agency of the Ministry of Justice of Georgia held a training for the representatives of the commercial banks. During the training, the main subject of which was fundamentals in Information Security, the representatives of commercial banks were trained in the introduction, and audit principles of the Information Security.

"The aim of the training is to introduce to the relevant personnel of the private or public organizations main goals and requirements of the Information security which are important for an organization to satisfy in order to forma, introduce, function, and improve Information Security Management System at

every stage. Data exchange Agency regularly holds similar trainings for the representatives of the subjects of critical infrastructure, as well as for the representatives of private companies, in order to improve the quality of carrying out Information Security and bring the standards in accordance with the international norms as required by the law on Information Security"- Irakli Lomidze, Head of Information Security and Policy Division of the Data Exchange Agency.

Training which took place from April 28 till May 2 was attended by the representatives of these banks: ProCredit bank, VTB bank, Bank of Georgia, and Bank Constanta.

The five-day training ends with test, on the basis of which the certificate of qualification is delivered.

MEETING HELD WITH STUDENTS UNDER THE MOU SIGNED BETWEEN THE MINISTRY OF JUSTICE OF GEORGIA AND THE GEORGIAN UNIVERSITY

Within the frames of memorandum signed between the Ministry of Justice of Georgia and the St. Andrew the First-Called Georgian University of the Patriarchate of Georgia, a meeting with students of the department of computer science and informatics was held.
